## **Minutes of the Monthly Parish Council Meeting**

Cllr P Robinson declared a prejudicial interest (and left the meeting when the item was to be discussed) in item 8e) Memorial Gardens Tree Work

- **1645. Public speaking** Mr Hawksley spoke regarding Lea Wood and past human activity in the wood (as document circulated to Cllrs) and it is proposed that essentially a community project plus ARS based in Bakewell are looking to investigate any historical possible findings and are asking the support of the Parish Council with the project, agenda item for December.
  - County Cllr Jackson spoke Crich Careline a team of volunteers of local based groups who will have training and will work with the District Nurses covering Crich, South Wingfield and Lea and Holloway who would visit the lonely and vulnerable but will be specially helpful during the winter and if we have bad weather and leaflets are being printed to give information for contacting the group. Cllr Jackson is also dealing with problems with school buses in the parish.

Cllr Shields spoke of the Parish Plan and the steering group are coming to a conclusion and the Parish Council will soon receive a draft copy and a formal plan will be presented in January 2012. Cllrs Shields, Wiser and the Clerk would meet to discuss details.

Cllr Wiser spoke of the Remembrance Service on Sunday November 13<sup>th</sup> 2011 and he would lay a wreath on behalf of the Parish Council, Cllr Robinson would look at the loose stone which needs repair.

Cllr P Robinson spoke regarding the Memorial Gardens (as he had declared a prejudicial interest) he was hoping to cut back rhododendron's and maintain the view from the Memorial. A site meeting had been held last year and during the meeting it had become evident that some tree work was necessary. Amber Valley Borough Council had also been on site and had given permission for a young Oak, a sickly Rowan and another tree to be removed.
