- **1818. Declaration of member's interests:** Cllr P Robinson declared a prejudicial interest in item 10) cheques as receiving a cheque for payment for work done, but would remain in the meeting as the spending had been previously agreed at another meeting Cllr M Wiser declared a prejudicial interest in item 7j) Proposal for Lea Primary School to use the Woodland Site as a natural Forest School site as Chair of School Governors and would leave the meeting

Mr Sauzier spoke of the progress with the Parish Council website and gave figures of an average of 11 pages a month viewed. The minutes and agenda have been updated and it is time for reviewing the website with necessary additional information and needs new additions and make better use of the website.

Cllr Hooker spoke of trees growing on the roadside on Mill Lane they are growing in the silt and stones in the gutters and Derbyshire County Council need to be made aware.

Cllr Wiser read out a statement clarifying a comment made at the previous meeting.

Mrs Aldred spoke of an application for a two hundred year old Oak tree to be felled and the application not being on the Amber Valley Borough Council website, written comments from Mrs Aldred had been circulated.

Cllr Else commented regarding a large hole on the footpath top the rear of the Doctor's surgery and electric fencing on FP 12.

The Clerk spoke of Derbyshire Dales Local Plan and dates for forthcoming meetings.

  - a) Christmas Tree Update, report from Cllr M Wiser, also advice from Came & Co. re Christmas Trees and Lights
    - **RESOLVED** Mr Foster would supply the cable required and install this, Mr Carter and Cllr Wiser would install the steel tube for holding the Christmas tree and Cllr Thorpe would confer with Mr Foster regarding the supply of Christmas lights as an individual he would be donating £100.00 for the purchase of new lights. The Parish Council instigated the idea of a Christmas tree for the Parish and now the Florence Nightingale Hall Committee will take over.
- b) 2012 Annual Main Play Area inspection report from AVBC Holt Lane, Lea Play area Discuss a By-Law for keeping off dogs and alcohol for the main play area and fencing for an area where dogs are allowed, a drawing of the site has been emailed to Cllrs RESOLVED the kerb at the roadside near the gate needs attention the Clerk is to contact Derbyshire County Council, the Rocking Horse needs to be removed as soon as possible as the

- safety testing has condemned the Rocking Horse as unsafe, the Clerk is to obtain quotations for fencing and mesh with a gate to be also installed.

  RESOLVED the Clerk is to respond to the letter stating that the matters have been referred to Derbyshire County Council.
- d) Gibbet Stone DCC approved the Parish Council maintaining the Gibbet Stone, now needs Securing and groundwork Work now completed by the Arkwright Society. The Clerk has not Written to the Arkwright Society due to the circumstances, therefore a decision is required regarding the account of £888.00 and work done.
  - **RESOLVED** the Clerk and the Chair Cllr Thorpe are to arrange a meeting with the Arkwright CEO to discuss the work done and report back to the Council.

- f) Handover of Lea Wood by Lea Wood Trust to Derbyshire Wildlife Trust letter received from Leawood Trust and Derbyshire Wildlife Trust, transfer to take place on November 30<sup>th</sup> 2012 – item for report
- g) Street light on Church Street, Holloway (Cllr Else) the Clerk has written to Derbyshire County Council regarding street light 49175, awaiting reply RESOLVED Derbyshire County Council responded stating they had received no comments regarding this light during the consultation period and they could see no reason to reinstate this light.
- h) Paint issue on the pavement / road out side Holloway Chapel the Clerk has written to Derbyshire County Council asking if they would clean the pain of the pavement / road, reply received from Derbyshire County Council
  - **RESOLVED** Derbyshire County Council had passed this on to AVBC
- i) Bus Shelter Church Street petition received from residents asking to provide a replacement Bus Shelter Micro stop Enclosure £2204.00 + £1695.00 for solar lighting = £3889.00 (50% DCC £1949.50 & 50% PC £1949.50 + VAT) Micro stop Enclosure with mains lighting £2204.00 + £2180.00 = £4384.00 (50% DCC £2192.00 & 50% PC £2192.00 + VAT) This price may vary because of the electrical quote. It is necessary for the PC to consult with the people living in close proximity of where the shelter is to be placed, this is the only shelter that could fit at that location
  - **RESOLVED** dependant on consultation with the residents in the locality and the Clerk to contact Derbyshire County Council regarding not having a light in the bus shelter as there is a light across the road, then to go ahead with having a micro stop enclosure installed.
