#### 2110 Councillor H Sheppard – New Councillor

The Chairman (Councillor Ian Hooker) formally welcomed Councillor H Sheppard to the Council.

**2111** Apologies for absence were received from Councillors M Shields and J Ward.

## 2112 Variation of Order of business

RESOLVED that in view of the public interest in the John Smedley Planning Application item 7 on the Agenda be considered at the conclusion of Public Participation.

#### 2113 Declaration of member's interests at meeting

Councillors M Wiser and S Chambers declared a personal interest in Agenda item 12 – Planning Application AVA2014/0277 and opted to remain in the meeting during discussion of this item.

## 2114 Public speaking – Suspension of Standing Orders

RESOLVED that in view of the public interest Standing Orders in respect of public speaking referred to at Section 3 (f) and (g) be suspended to allow all 19 members of the public the opportunity to speak at the meeting if they wished.

## 2115 Public Speaking

Eight residents spoke of their objections to the John Smedley Planning Application. The main objections were the development of houses which were unsympathetic to the surrounding area on a green field site. Concern was also expressed at the traffic issues ensuing particularly off street parking, the pressure on local services caused by the development, the impact on the Derwent Valley Heritage Site and the demolition of existing buildings.

Amber Valley Borough Councillor D Taylor could not comment on the John Smedley application (because he is a member of the Planning Board) but requested all objectors to include him in the circulation list of any representations made to allow him to be fully informed when this application was considered by the AVBC Planning Board. He also reported that the political control of AVBC had changed to Labour control.

PC D Chambers 886 reported that only one recent crime had been reported in respect of the theft of walling stone and the alleged culprits had been identified by vehicle recognition. He also reported that the Police were to conduct an Automatic Traffic Count Speed survey on Lea Road Lea Bridge in the absence of any recent traffic data. Leashaw and Lea Main Road did not have any collisions or casualties in the last three years of available data. The Belper Rural Safer Neighbourhood Team considered that Leashaw was not suitable for speeding enforcement because of inadequate site lines and safe places to stop a vehicle in the 30mph section. Enforcement visits had been made to Lea Main Road but found it quiet with no tickets being issued. He was to consider any further action between 8.00am and 9.00am and 4.00pm and 5.00 pm

#### 2118 John Smedley Planning Application

It was reported that one resident had circulated an email appealing for residents to submit their comments on the application and one resident had copied in the parish council on his submitted objection on heritage issues and the "out of scale and character of the proposed housing. One resident had submitted a letter on behalf of his Mother outlining her objections made to Amber Valley Borough Council.

Council Members then made individual contributions in respect of the resident comments made at the meeting and the letters received.

RESOLVED that whilst the Council supports the general terms the redevelopment of the brown field site and the conservation of the historic buildings on the site an objection be made to the application because of the inclusion of the three storey block proposed on the green field site at the northern edge of the development which is out of keeping with the general look and scale of the existing buildings, the traffic issues at peak periods and associated matters in respect of sewage disposal and local services and would seek further information and discussion on the proposed S106 agreement and the affordable housing aspects.
