Minutes of the Monthly Parish Council Meeting

Held in Christ Church Parish Room Holloway Wednesday January 8th 2014 at 7.00pm

- 2031. Public speaking A resident spoke of his concern regarding road safety issues at the following locations: a) Top of Sledgegate Lane b) Common End c) Holt Lane d) Long Lane., he felt there was a case for installing traffic mirrors at these junctions. Cllr Wiser suggested he should contact Derbyshire County Council and County Cllr Martin Tomlinson and express his concerns to them as these are highway matters and it would be helpful if others wrote to them with their concerns too.

A resident spoke of wanting to correct the minutes and it was explained to her that the members of the public cannot amend minutes. The resident asked if she could speak to a Cllr and was told yes, however no Cllrs can make any decisions, only the Council can make decisions.

A resident spoke of past monies raised by adding a pound per annum onto the precept and put into a cemetery fund, the money was then used to purchase the picnic site with a view to use this as an extension to the cemetery. However the land proved to be unsuitable and now the land has been sold the resident is concerned about what will happen to the money from the sale of the land as there is no provision for land to use as a cemetery.

Borough Cllr D Taylor spoke of the planning applications which had been submitted to Amber Valley Borough Council over the last year. There were a total of 971 applications, 97% were delegated, 3% were dealt with by the Planning Board, 28 were approved with conditions and 5 were refused. Cllr Wiser asked how many were retrospective applications? Cllr Taylor could not say but they do go through. Cllr Wiser spoke of cases previously in the parish and Enforcement is rather timid. Cllr Taylor spoke of AVBC internal look at Enforcement, however AVBC have enforced their first possession order this year.

Cllr Shields spoke of the development of 40 lodges at Longway Bank which had been appealed; the hearing is to be held on January 21st 2014 at 10.000am at Matlock.

Cllr Hooker asked Cllr Taylor about recycling as, previously, Cllr Taylor stated that the recycling could not deal with Tetra Paks, Cllr Hooker spoke of a site in Yorkshire which now takes these. Cllr Taylor stated he would follow this up.

Cllr J Ward asked the Council if they had any plans for commemorating the WW! Centenary? This would be an agenda item for the February meeting.

The Clerk gave the police apologies and their report which stated there had been no crimes in the parish other than one incident.

 RESOLVED the Clerk is to email the chosen circular picnic tables and to obtain quotations for two new goal posts similar to the ones on the play area and Cllrs Thorpe, Robinson, Wiser and Chambers would remove the old swings.
