2362 Apologies for absence - Councillors Mike Taafe-Finn and Joan Ward.

#### 2363 Variation of Order of business

**RESOLVED** to bring forward agenda item 13 (3) "DLH Womens Institute request for Parish Council support in applying for a Community Leadership Fund Grant of £400 to purchase a defibrillator", to be considered under the Public Speaking Item. In addition, it was noted that the Chairman had agreed to accept an urgent item of business, a Planning application received from DCC relating to erection of 1no. galvanised steel shed, installation of a multiuse games area, Lea Primary School, Church Street, Lea, to be considered under the Planning agenda item. The reason for urgency being that a response was needed by 22<sup>nd</sup> June, 2015 which was before the next meeting of the Council.

2364 Declaration of member's interests - None.

#### 2365 Public speaking

A member of the Women's Institute spoke in relation to their plans to purchase a defibrillator for location at one or two potential sites that were currently under consideration and were seeking the Council's support for the submission of a bid for grant funding from Councillor Taylor's Community Leadership Fund in the sum of £400. Further advice was being sought on the most desirable location via the Community Officer at the East Midlands Ambulance Service, following which it was intended to make a formal application to the British Heart Foundation. Confirmation was given by Councillor Taylor that the WI could submit a bid

directly themselves for this funding and the Council noted their intention to proceed on that basis.

Councillor David Taylor (AVBC & DCC) reported that the Council's bid for funding from the Community Leadership Fund for Speed signs to be located at key sites in the villages had regrettably been declined. He reported that he had taken on additional responsibilities following the recent elections having been appointed as Cabinet Member for Housing and Public Health at AVBC and also as Deputy Chair of Planning.

**RESOVED** to approve the minutes as a correct record.

(a) Goalpost – update on pursuit of revised quote for repairs/relocation of existing post

**RESOLVED** that approval be given to the updated quote for these improvement works in the sum of £440 as reported to the meeting and the contractor be requested to proceed on the terms set out.

(b) Plans for redundant rocking horse and consideration of parishioner request for removal from storage and a compensatory donation to the Scouts

**RESOLVED** that (1) approval be given for Councillor Barbara Wright to attend the yard to take photographs of the rocking horse and enquire about it's value and to consider disposal options to feedback to the Council and (2) consideration of a donation to the Scouts be deferred pending the outcome of (1) above.

(c) Update on pursuit of quote from AVBC for safety inspection remedial repairs and provision of litter bin and signage

**RESOLVED** that (1) approval be given to the quote for remedial repair works to the play equipment as set out in the quote from AVBC in the sum of £501.25 + VAT, but excluding the repairs to the swing washer/nut replacement which had already been addressed by the

Council; (2) AVBC be requested to dispose of the broken spring chicken and the heavily worn spring plane and (3) approval be given to the design and supply of the "Ownership sign" for the Play area designed by AVBC for the supply, only together with fixings, to be fitted by the Parish Council and they be requested to revise their price quotation accordingly.

- 2371 Memorial Gardens Feedback on enquiries made into Community Payback Volunteers undertaking works to cut back vegetation and scope for pursuing a grant RESOLVED to note the feedback from Councillor Barbara Wright that the Probation Service can provide Payback Volunteers to undertake this work for free on a one to one supervised basis although a preliminary site visit/health and safety inspection was required first. The Council authorised Councillor Wright to arrange this site inspection and to attend and meet the Probation Service representative and feedback to the Council before any final approval was given to proceed.
