The Chairman announced that Cllr Aldred would be recording the meeting.

2931. To receive apologies for absence - Cllrs P Ward, B Wright, S Hannath

2932. To consider motions for variations of business - None

2933. Declaration of member's interests at meeting

Councillor Aldred declared a disclosable pecuniary interest in Item 15 Planning Matters (Planning application TRE/2017/0138).

2934. Public Speaking

A resident raised various concerns about the comments put forward by the Parish Council in connection with Planning application TRE/2017/0128.

The Police representatives gave an update on the crime figures and reported that no crimes had been reported in September. There was a discussion about discrepancies on crime statistics and Holme Close. The officer agreed to check the statistics on the Police UK website.

2935. To approve and sign the minutes of the meeting held on 6 September 2017.

The Chairman clarified that the minutes only need to be a record of decisions made by the parish council and not a full account of everything that is said.

RESOLVED: To change the penultimate sentence of minute 2922 to read 'Cllr Aldred raised concerns that the representative from Futures Housing was not aware of any incidents, despite there being 4 incidents recorded for June and July on police.uk and that the parish council should make a complaint to the Housing Ombudsman or the CQC'. Vote: 4 for, 1 against, 1 abstention.

2937. Chairman's Announcements

 A response has been received from Lea Green regarding the noise issue and the manager was apologetic.

RESOLVED: For the Clerk to ask Lea Green if they could provide a contact telephone number for the duty officer on site so that they could be contacted should a problem occur in the future.

- The gate at the entrance to footpath 20 on Long Lane has now been installed.
- The seat on Mill Lane, Dethick, (at junction with Footpath 1) is broken.

Cllr Sheppard and Cllr Taaffe-Finn gave an update. A possible site was the field next to Jug and Glass. However, the turf would need to be removed to accommodate the bonfire and re-laid afterwards. Access into the field was also discussed.
