### MINUTES – 7 October 2020

Minutes of Dethick, Lea and Holloway Parish Council meeting held by video conference on Wednesday 7 October 2020.

3773. To receive apologies for absence - None

3774. To consider motions for variations of business - None

### 3775. Declaration of member's interests at meeting

The Clerk declared a personal interest in item 26 and indicated that he would leave the meeting when the item is discussed.

### 3776. Public Speaking

A young resident requested a basketball hoop for Lea recreation ground and highlighted that there was very little for older children. The nearest play area with better facilities is Crich. Having better facilities would encourage young people to get out of the house and get fit. Potential locations for the basketball hoop were discussed.

## 3777. To approve and authorise the Clerk to sign the minutes of the meeting held on 2 September 2020

**RESOLVED:** To approve and authorise the Clerk to sign the minutes of the meeting held on 2 September 2020.

### 3778. Consider applications for two Parish Councillor vacancies

**RESOLVED:** (1) To co-opt S Dewhirst as a Parish Councillor. (2) To re-advertise the remaining vacancy, with a deadline in December and consider applications at the January meeting.

## 3779. To determine which items, if any of the Agenda should be taken with the public excluded

**RESOLVED:** To deal with item 26 under 'Confidential Items' with the public excluded.

#### 3780. Chair's Announcements

- The Chair passed on the news that former parish councillor, Bert Sheppard had sadly passed away in July, but we only found out in September. Condolences to be passed on to the family on behalf of the Parish Council.
- Matlock Town Council will be agreeing the process for the joint Speedwatch initiative at their October meeting. It has already got the go-ahead and they are working with Wirksworth so they will hopefully be in touch in the near future.

### 3781. Covid-19 Crisis – Parish update

Cllr Ward gave an update. There have been around 27 Covid cases in Crich and Holloway, 28 cases in Matlock and 61 in North Derbyshire. Nottingham and Belper figures are also high. It was highlighted that there are cases at Highfield school.

## 3782. Review cemetery fees and consider adding a change to cover the administration cost for exhumations

**RESOLVED:** To charge a fee of £200 to cover the administration cost of future exhumations.

# 3783. Consider participation in Royal British Legion - Derbyshire Lamp Post Poppy Campaign 2020

**RESOLVED:** (1) To participate in the Derbyshire Lamp Post Poppy Campaign 2020 by putting up and re-using the existing poppies. (2) To make a donation of £25 to the Royal British Legion.

### 3784. Consider the purchase of Christmas trees for the parish

**RESOLVED:** To purchase one Christmas tree in the region of £100 for outside the Florence Nightingale Memorial Hall.

### 3785. Complaints regarding missed refuse collections

**RESOLVED:** For the Clerk to write to AVBC to complain about the poor service being experienced and that several residents have raised issues about missed bins.

## 3786. To reconsider provision of a new access path at the southern end of the cemetery – CIIr Stevenson

**RESOLVED:** For the Cemetery and Memorial Grounds Working Group to meet on site to consider the path and make recommendations to a future parish council meeting.

### 3787. Consider providing a basketball hoop at Lea play area – Cllr O'Neil

**RESOLVED:** (1) For the Play Area Working Group to meet and look at the feasibility of providing a basketball hoop in terms of location and cost and report back to a future parish council meeting. (2) For the clerk to circulate contact details of potential

suppliers. (3) For Cllr O'Neil to draft an article for the parish magazine to give some background to the proposal and see if there's anyone prepared to help with funding.

## 3788. Consider the maintenance of small garden on the green opposite the Florence Nightingale Memorial Hall – Cllr Ward

Cllr Ward explained the background to the item. Cllr Crossley and Cllr McDonald offered to maintain the garden going forward.

## 3789. Update – Public access to defibrillators located at Lea Primary School and Lea Green / Provision of another defibrillator in Lea

The Clerk confirmed that Lea Green have offered to provide a sign advertising the defibrillator on site. All three defibrillators will be advertised on both websites and the parish magazine. Cllr McDonald confirmed that there was no sign on the school gate as yet, but there is full time access to their defibrillator, with a buzzer system during school hours.

**RESOLVED:** Not to provide another defibrillator in Lea, since there are now three that are publicly accessible within the parish.

### 3790. Update - Housing placements - Hillside, Holloway, Derbyshire

**RESOLVED:** (1) For a meeting to be set up with Futures and residents so that the issues can be raised. (2) For the Clerk to add an item to the next agenda so that an update can be given.

## 3791. To accept the offer of £250 funding from DLH Together towards the Florence Nightingale signage

**RESOLVED:** For the Clerk to formally accept the funding and pass on thanks to DLH Together.

# 3792. Update - Holloway gateway signs for Florence Nightingale Anniversary The Clerk confirmed that a final quote had been requested and the Object in the Highway Licence application would be sent off to DCC in due course.

# 3793. Update on information board for Florence Nightingale Anniversary and consider proceeding with order and planning application (fee £231)

**RESOLVED:** (1) To proceed with the planning application for the information board at a cost of £231.00. (2) To place the order with DAB Graphics for the information board after the final version of the artwork has been circulated to parish councillors and any corrections made.

### 3794. Update – Climate Change Working Group – Cllr Crossley

Cllr Crossley gave an update. The article has gone out and people have come forward wishing to join the group. A Zoom meeting will be arranged for the group in due course. The Crich climate change meeting was cancelled due to Covid restrictions but communications will be maintained.

3795. Update – Dethick, Lea and Holloway Heritage and Conservation Action Group Cllr Crossley gave an update. A Zoom meeting took place regarding the Neighbourhood Plan and actions were taken forward. Newsletters have gone onto

both website and the parish magazine. Costs are being obtained for banners to advertise the SHELAA. The group has commissioned a number of independent heritage reports.

### 3796. Update on Neighbourhood Plan

Cllr Ward confirmed that an update is due this month from AVBC on the SHELAA sites and which ones have been included as developments.

### 3797. Update on Community Speedwatch

Cllr O'Neil gave an update. The group has been out for the last 3 weeks in Lea and Holloway and will be doing Lea Bridge next week. The majority of motorists doing over 36mph are not local. Another group meeting will be arranged in the near future.
