4025. To consider motions for variations of business

4026. Declaration of member's interests at meeting

Councillor Farnsworth declared a personal interest in planning application AVA/2020/0615 and indicated that he would remain in the meeting but not participate in any discussions or vote.

4027. Public Speaking

The planning applicant for AVA/2021/0460 (Prospect Cottage Farm Main Road Lea) explained that information was being circulated which was incorrect. There is no intention to have heavy plant or machinery on site. It will be a purely agricultural operation, mainly sheep.

The provision of allotments was considered and it was felt that given the response from John Smedley Ltd regarding the football pitch, there was little point in asking about allotments. It was noted that a resident had offered to take the lead on allotments and the parish council would be able to give advice if required.

4042. Planning Matters – Planning applications for consideration

AVA/2020/0615

Lea Hurst Leashaw Holloway Matlock Derbyshire DE4 5AT Siting of two glamping tents for tourism use (The proposal may affect the setting of a Listed Building)

COMMENT: Objection

The Council objected to the initial proposal in August 2020 (Document 1042898). It cited the following reasons at that time:

- The proposal will bring substantial harm to the setting of the Heritage Asset;
- The proposal is alien in form and type within the historic setting of the walled garden and conflicts with the heritage value of the setting of Lea Hurst;
- At no time have there been structures of scale and size similar to those proposed within the walled garden;
- The proposal will have a substantial impact on the site's designation within a Special Landscape Area, the Conservation Area and the setting of the DVMWHS;
- The proposal will result in a significant increase in traffic movements via an acknowledged substandard entrance and driveway;
- The proposal will have a significant impact on the well-being of neighbouring properties and those persons residing in reasonably close proximity.

The Council re-affirms these objections and believes that they have been borne out by subsequent reports from the Authority's own Heritage Consultant, Pollution Officer, the Highway Authority, DVMWHS commentary and a considerable volume - over 100 - individual Objections from people in the vicinity.

The revised application reduces the scale of the proposal: it does not address many of the in-principal concerns raised in this body of Objections concerning heritage impact, visual impact within the setting of a listed building, traffic movements, parking, access safety, waste management, noise management, foul and waste water drainage and so on.

We would point out that Map 12 on page 48 of the now affirmed DLH Neighbourhood Plan does not include the proposed site within the Built Framework of the settlement and that the Heritage Consultant's view is that...'the house and surrounding landscape are so intimately associated with it [the adjacent Special

Landscape Area], that they cannot realistically be considered as
separate. The Wardell Armstrong landscape study of 2016,
commissioned by Amber Valley Borough Council, concluded that
all the land round the settlements of Lea and Holloway was of high
landscape sensitivity, including the application site.'

AVA/2021/0460

Prospect Cottage Farm Main Road Lea Derbyshire DE4 5GR Proposed replacement agricultural building to house and feed livestock and to store fodder and implements and new access track

COMMENT: Objection

Having viewed the amended plans, the Council still has concerns about the doubling in footprint of the new agricultural building, and its visual impact within the Conservation Area given its proximity to the Grade II Listed Lea Chapel. The proposal for additional landscaping measures may well be helpful in screening the mass of the building though these would need substantial planting around the whole northern field edge to be effective.

The revised layout of the track access is an improvement on the original application but is still a cause of concern. As proposed, it will require extensive loss/re-orientation of drystone walling and we would urge AVBC to ensure proper conservation of walling type should the application be approved.

The Council is concerned also that there is no assessment of potential lighting requirements and light pollution or the noise impact on adjacent properties. The proposals relating to the soakaway remain unclear and we would be concerned that any such installation is able to cope with any future likely volume of waste. The proposals also reject the need for either a biodiversity survey or an archeological survey and we feel these should be considered.
