Cllr Taylor has offered to provide funding and the event will include refreshments, display boards, Derbyshire Wildlife Trust, AVBC climate officer, the Horticultural Society, bee hives and more. Further funding should not be required.

AVA/2021/0769 | Holt Cottage Holt Lane Lea Matlock Derbyshire DE4 5GQ

Demolition of existing pig-sty and erection of building to form holiday accommodation, and associated landscaping works (may affect the setting of a conservation area)

COMMENT:

Objection

The Council have two principal concerns about the proposal: its scale and the intended use of materials.

Scale: the application does not provide any dimensions but it is clear from the footprint drawings that the new building will in effect be a new one-bedroom, single storey dwelling which is considerably more than twice the area of the old pig building.

Materials: the proposed dark metal roofing to the proposed extension together with metal window frames and wood cladding do not conform with the Neighbourhood Plan criteria concerning building design. The Design Principles set out in the DLH

Neighbourhood Plan state in Chapter 14, 'The Importance of Good Design', (page 69 dealing with Lea) that: 'A simple palette of materials should be maintained for the village, as laid blocks in local gritstone are the predominant finishes. Introducing new materials should be avoided, especially for the main streets. Simple roofs with clay or slate tiles are encouraged. Windows with a vertical emphasis are encouraged, and window bars should be included. Sash windows are commonplace and add character.'

As the site lies within a part of the DLH Conservation Area which is very rural in character, close to the Lea Green Centre boundary and abutting a public pathway, we would like to request that the Heritage Officer's advice is sought regarding the proposal. The restoration of the Georgian/Victorian piggery is very welcome, reusing as it does, original stones and reclaimed Staffordshire blue clay tiles. If these materials could be carried through to the extension itself a more sympathetic scheme might be enabled.
