**2403** Apologies for absence – Councillor Barbara Wright.

2406 Public speaking

A number of parishioners spoke in relation to the proposed reinstatement of a former access track to Lea Hurst, Holloway, AVBC Planning application AVA/2015/0531. Comments included:-

- The application refers to re-instatement of the track which would simply only need the top soil taking off. The proposal is much more than this and should therefore be re-labelled "development"
- The applicant is simply wanting to re-instate the trackway and this proposal has my full support. This is similar to a recent application across my dwelling to re-instate a footpath. I believe it is ridiculous for villagers to argue against it
- Is the application for a footpath? My understanding is that it is for a double track and therefore for vehicular access. Inevitably, this will increase the number of vehicles using the junction outside the Doctor's surgery, which is a bit of a blind summit. We are now in the 21<sup>st</sup> Century and these will be very different types of vehicle that would access this property. Additionally, the applicant does not state his intent within the application, why is it required?
- It is not long since a similar application here was submitted and rejected. It is simply the same intention wrapped up under "the historical perspective"

- There should be a ban on vehicular traffic using the track and it simply being used as a footpath
- Only tractors and agricultural vehicles have used this field during the 41 years that I have lived locally and viewed the site. It has only seen people on foot and would be a shame from a conservation perspective
- I wish to object on conservation grounds similar to the previous recent refusal .It is not a Drive and never has been. There are maps that show that this was a path, one from 1868 showing the track and a picture from 1950 showing the track and path to Lea Hurst. From a heritage perspective, the Inspector on appeal said that this would not enhance the setting of this listed building. The Highways Authority two years ago also commented to me that a new access if permitted would be expected to be better than currently exists with improved sight lines. To conclude, the Parish Council should reject it
- Is there any way that traffic can be banned from the track? Is this solely for the applicant and his family's use and would access be controlled by an electronic gate? It is such a busy area, blind hill and a busy junction. Has the Highways Authority been out for a site visit?
- The applicant was in attendance and indicated that it was the history of the site that drew him to purchase the property recently and his aim was to restore the setting and carriageway to this important house. As a historian by training he confirmed that he had no plans whatsoever to widen the carriageway for a future housing development in the field. It was to be used only as access by his family and family visitors.

AVBC Councillor David Taylor had no comment to make as a member of the Planning Committee and was purely here to listen to the debate on the application. He did confirm that the other application on the agenda for consideration this evening, AVA/2015/0101 Former Picnic Site, Lea Moor Road, Lea, Erection of two timber framed, ecologically friendly, cabins for use as holiday accommodation (Amendment to proposal), was to be considered at the Planning Board on 17<sup>th</sup> August.

The Chairman had two announcements to make; (1) that the County Council Digital Derbyshire Team had arranged for faster broadband speeds for the village brought to two Green Cabinets, the first on Church Street and the second outside the Jug and Glass in Lea. Residents would be able to check on the Digital Derbyshire website whether these faster speeds were available for their household and (2) A notice had been displayed in the Doctors Surgery regarding the importance of using the Dispensary within the premises. He urged residents to use the facility as this was vital to the continued existence of the local surgery. It was a case of "use it or lose it".
