2652. Apologies for absence – Cllr Mike Taaffe-Finn

2653. To consider motions for variations of business - None

2654. Declaration of member's interests at meeting

Cllr Aldred declared a personal interest in planning application AVA/2016/0629 (Item 19) and indicated that she would remain in the meeting, but not participate in any discussions or vote.

Cllr P Ward and Cllr Hooker declared a personal interest in Item 18 - Flood risk due to damaged kerb. They both indicated that they would remain in the meeting, but not participate in any discussions or vote.

2655. Public Speaking

One person registered disappointment that the access track to Lea Hurst that is currently being constructed, does not currently have grass running down the middle and hoped that this would be rectified.

One person raised concerns in relation to new design put forward as part of planning application AVA/2016/0629. A number of issues were highlighted including size, the use of a flat roof and materials which were not in keeping with the conservation area character statement. Impact on wildlife, light pollution and the presence of tunnels of historic importance were also mentioned.

One person highlighted a potential flood risk due to properties due to a damaged dropped kerb on Unnamed Road, Lea Wood. The problem had been reported to Derbyshire County Council some time ago, but they had not carried out the repair. A request was made for the parish council to consider writing to Derbyshire County Council in the hope that this would help to get the problem dealt with.

2660. Neighbourhood Area Designation

RESOLVED: (1) For the neighbourhood area designation to be the Dethick, Lea and Holloway parish area. (2) For the Clerk to write to Amber Valley Borough Council and inform them that the Parish Council wishes to proceed with a Neighbourhood Development Plan and inform them of the neighbourhood area designation.

2661. To authorise a Neighbourhood Development Plan Steering Group with power to act as a Committee of the Parish Council, but with its authority in financial matters to be limited to the amount of grant funding received on behalf of the Council. The Steering Group so authorised will adopt a constitution under which it will control its affairs. The constitution will be subject to approval by the Parish Council.

The Steering Group so authorised will adopt a constitution under which it will control its affairs. The constitution will be subject to approval by the Parish Council. The terms of reference the Steering Group will be to develop a Neighbourhood Development Plan for Dethick, Lea and Holloway'. (2) To take forward and accept the amended proposal.
