MINUTES - 5 October 2016

2675. Apologies for absence – Cllrs Steve Hannath and Pat Ward

2676. To consider motions for variations of business - None

2677. Declaration of member's interests at meeting

Councillor Ian Hooker declared a personal interest in Item 14 (Consider quotations for repairs to the Receiving House) and indicated that he would remain in the meeting but not participate in any discussions or vote.

2678. Public Speaking

Three residents raised further concerns about the flats at Holme Close, Holloway and stated that Futures Homescapes were housing former criminals. They were disappointed with the previous response from Futures Homescapes and stated that Futures Homescapes were abdicating responsibility to the Police. The residents claimed that one particular person was responsible for a number of thefts. An incident where a school teacher was frightened and instances of begging outside the shop were also mentioned. It was claimed that vulnerable residents were too frightened to report the problems and that the location of the mobile Police station was putting people off speaking to the Police as the mobile unit was close to the flats.

RESOLVED: (1) Clerk to pass on the concerns of residents to the Police and Futures Homescapes and invite them to a meeting with concerned residents. Ideally this would take place immediately before a future Parish Council meeting so that the hall was available. (2) Clerk to ask the Police to consider parking at an alternative location to Holme Close when they visit with the mobile unit.

RESOLVED: To approve the minutes as a true record.

2681. Chairman's Announcements

Adding volunteers to Parish Council Insurance

RESOLVED: To add 6 volunteers to the Parish Council insurance policy which would be free until June 2017 and then £14.40 when the policy is renewed.

Application to designate Neighbourhood Area for DL&H parish

The Chairman explained that he had received confirmation from AVBC that the Neighbourhood Area had been agreed for the purposes of the preparation of a Neighbourhood Plan.

Road priority survey

The Chairman explained the background to the survey and gave the opportunity for another Councillor to submit a response to DCC.

Poppy Appeal donation for Remembrance Day wreath

RESOLVED: For the Parish Council to make a donation of £50 for the Remembrance Day wreath.

2682. Update on Neighbourhood Development Plan

The Chairman gave an update on the meeting held on 21/9/16. Attendance was disappointing and only 14 people were present including 4 Parish Councillors. A Chair was not elected, but Guy Martin was able to answer questions raised. The constitution will be considered at the next meeting 25/10/16.

2683. Correction to item 25b of Standing Orders

RESOLVED: To correct item 25b of Standing Orders as follows: -

A motion to add to or vary or revoke one or more of the council's standing orders, except one that incorporates mandatory statutory requirements, shall be proposed by a special motion, the written notice by at least 4 councillors to be given to the Proper Officer in accordance with standing order 9 above.

2684. To authorise the Clerk to proceed with repairs to the swing and play trail at Holt Lane Recreation Ground once a suitable quotation has been received

RESOLVED: The Clerk to proceed with repairs to the swing and play trail providing the cost in within the £500 limit.

2685. Memorial Gardens Footpath - Proposed Public Footpath Creation Agreement Under Section 25 Of The Highways Act 1980

RESOLVED: (1) For the Clerk to confirm to Derbyshire County Council that the Parish Council wish to proceed to convert the existing footpath through the Memorial Gardens into a public footpath under Section 25 of the Highway Act 1980. (2) For the footpath retainers mentioned by Derbyshire County Council to be repaired as part of the HLF project.

2686. Memorial Gardens HLF Project Update - Cllr J Ward

Cllr Joan Ward gave an update on the project. A small number of volunteers were continuing to clear and tidy the area. The gentlemen in the adjoining property was thanked for disposing of rubbish, as was Cllr Joan Ward to her continuing work on this project.

2687. Consider revised 'High Priority' work schedule from tree inspection / risk assessment report from Thompson Tree Services, having removed works being carried out as part of the Memorial Gardens HLF project

RESOLVED: (1) Clerk to obtain 2 further quotes from a contractor who is approved by the Arboricultural Association for the tree work identified in the report as soon as possible. (2) Clerk to contact DCC and ask for the tree work identified as T4 at Holt Lane Recreation Grounds to be undertaken by them since the tree is on the highway side of the wall.

2688. Consider quotations for repairs to the Receiving House

RESOLVED: To proceed with the quotation from Roger Elliott priced at £5450.00.

2689. Consider quotation for the provision of a facia and snow guard on the shelter at Lea Recreation Ground

RESOLVED: To proceed with the quotation from Derek Meakin priced at £375.00.

2690. Consider quotation for Internal Audit 2016/17

RESOLVED: To proceed with the quotation from Brian Wood priced at £150.00.

2691. Public House Car Park - Cllr Aldred

Cllr Aldred raised concerns about the condition of the car park at the Yew Tree public house especially the overgrown vegetation and surfacing.

RESOLVED: Cllrs Joan Ward & Joy Stevenson to visit the owners to ask informally if the area could be tidied up.

2692. Parish Boundary update – Cllr Aldred

Cllr Aldred gave an update on investigations she had undertaken concerning the parish boundary and confirmed that the boundary was actually correct.

2693. Reinstated track at Lea Hurst – Cllr Stevenson

Cllr Stevenson highlighted concerns with the appearance of the reinstated track, as it does not meet the requirements of the planning decision. However, AVBC stated that the work is still in progress. Cllr Hooker explained that he had spoken with the owner and there is to be a further top layer of gravel added to the path and then grass seed will be sown in the middle of the path. Given the time of the year this would not be done until the Spring.

2694. TPO refused by Derbyshire Dales District Council in respect of the trees at Brookdale, Riber Road, Lea – Cllr Stevenson

RESOLVED: Clerk to contact the Head of Service or Chief Executive at Derbyshire Dales District Council informing them that the Parish Council is unhappy with the decision by the Tree Officer to refuse a Tree Preservation order as the tree is close to a conservation area and is within a special landscape area.
