2552. To elect a temporary Chair

RESOLVED: Councillor Bert Sheppard was elected as temporary Chair.

2553. Apologies for absence – Councillor Ian Hooker

2554. To consider motions for variation business - None

2555. Declaration of member's interests at meeting

Cllrs Steve Hannath and Pat Ward declared an interest in planning application AVA/2016/0080 and stated that they would not participate in the discussion or vote on the item. However, the Chair confirmed that it would be in order for them to remain in the room.

2556. Public Speaking

One member of the public spoke in relation to planning application AVA/2015/1097. The importance of requesting an 'Article 4' order was highlighted and a number of concerns were raised. It was also stated that the planning information was full of inaccuracies and there was no mention of replacing trees.

Three people spoke in relation to planning application AVA/2016/0080. A number of concerns were put forward including the size of the area and the construction of the surfacing. Attention was drawn to three objections that had been put forward to the planning department. It was also felt that this was development by 'stealth' because of the retrospective nature of the application and how it had evolved.

2559. Chairman's Announcements

The Chair announced that that the bus consultation was on the agenda to be discussed.

2560. DALC Subscription 2016/17

RESOLVED: To opt for the basic subscription priced at £237.57

2561. Update on HLF application for Memorial Gardens

Councillor Joan Ward gave an update on the HLF application and confirmed that it would be 8-12 weeks before a decision would be made

2562. Consider quotations for repairs to memorial shelter roof and path

RESOLVED: (1) To delay having the work carried out to allow time for the HLF to make a decision on the funding application. (2) Clerk to write to Smedleys to explain the situation regarding the HLF application and ask if they would be prepared to contribute to the repairs should the funding application be unsuccessful. (3) To appoint R Elliott to carry out the repairs and establish whether he could carry out the work by 7 July 2016 if he was given approval to start early June 2016. (4) Bradshaw & Green to be reserve contractor should R.Elliott be unable to carry out the work by the required deadline. **Vote:** 7 for / 1 abstention

2563. Preparations for Neighbourhood Plan Public Meeting (7 June 2016 at 7pm) Cllr Pat Ward informed the group that she had recently attended a Neighbourhood Planning roadshow organised by Rural Action Derbyshire (RAD). At the roadshow a representative from RAD offered to help with the organisation of the public meeting and speak. However, it had not been established whether this was free of charge.

RESOLVED: (1) A meeting to be arranged to discuss arrangements for the public meeting and report to the Parish Council meeting in May meeting. (2) Cllr Pat Ward to suggest a date, time and venue for the meeting.

2564. Repairs to Receiving House

RESOLVED: (1) Clerk to obtain a quotation for an asbestos survey for the Receiving House and proceed to place an order if the cost is less than £500. (2) Following the asbestos survey, Clerk to obtain at least 3 quotations for the work described in the Erskine Hunt report and also the re-glazing of the windows so that the building is weather proof. (3) Any Councillors wishing to see the inside of the Receiving House should meet on site at 6pm ahead of the June meeting on Wednesday 1 June 2016. (4) Cllr Aldred to investigate funding opportunities available through Derwent Wise.
