MINUTES - 2 February 2022

Minutes of Dethick, Lea and Holloway Parish Council Meeting held in the Florence Nightingale Memorial Hall, Yew Tree Hill, Holloway on Wednesday 2 February 2022.

4214. To accept apologies for absence - Cllrs J Dennis, S Farnsworth and P Ward

RESOLVED: To accept all apologies received.

4215. To consider motions for variations of business - none

4216. Declaration of member's interests at meeting

The Clerk declared a personal interest in item 25 and indicated that he would leave the meeting when the item is discussed.

4217. Public Speaking

The owner of Mayfield Stores, Holloway told the meeting that the shop was on the market and that some customers have said they are concerned that the shop may not continue when the property is sold. The shop also includes the post office. It was highlighted that there are options for the shop to be run by the community and a brief outline of these was given.

A member of the public expressed a wish to fund a memorial bench on High Lane for her late father who regularly walked the area and enjoyed the view from this location.

PCSO Worrall introduced himself and his colleague and gave a summary of crime in the area. It was highlighted that this is one of the safest parishes in the area.

A resident who spoke on behalf of himself and some neighbours detailed various objections to planning application AVA/2022/0013 - Land Adjacent Waterworks House Main Road, Lea (Erection of 2 dwellings). Objections were detailed and related to design, layout and impact on neighbouring property, heritage and landscape protected assets, habitats and biodiversity, flood risk & water impact, and environment & sustainability.

4220. Consider applications for parish councillor vacancy and agree closing date for second vacancy

When approval to proceed with the 2nd vacancy has been received from AVBC, the closing date will be 2/4/22.

RESOLVED: To co-opt Siân McKay as a Parish Councillor.

4221. To determine which items, if any of the agenda should be taken with the public excluded

RESOLVED: To deal with item 25 under 'Confidential Items' with the public excluded.

4222. Chair's Announcements

- The public meeting about Lea Road closure will be on 22/2/22 at 7pm in the Florence Nightingale Memorial Hall. Representatives from DCC will be at the meeting to give information and answer questions.
- Wildflower areas are being developed at the bottom of Hillside and below Holme Close by Futures Landscapes.

4223. Consider suggestions regarding Mayfield Stores, Holloway

The options regarding Mayfield stores were discussed and it was generally agreed that it was a good idea in principle, but there were concerns as to whether there would be sufficient interest and volunteers to take the ideas forward. It was highlighted that it was early days as the shop had only just been put on the market.

It was suggested that the owner should consider putting an article in the parish magazine setting out the options. The owner was also asked to keep the parish council informed of any developments.

4224. Consider resident's request for bench on High Lane

The clerk explained that permission would be required from DCC to site a bench on the verge. Cllr Stevenson confirmed that she was waiting a response from them as to whether an objects licence would be required.

RESOLVED: For the clerk to give an update to the resident when a response has been received from DCC.

4225. Consider future of Methodist Chapel – Cllr Stevenson

Cllr Stevenson explained that the future of the chapel was in doubt due to insufficient members. A Church Council meeting is scheduled for 14 February in relation to this.

RESOLVED: Clerk to send letter to the Church Council in support of the chapel and highlight its importance to the community.

4226. Feedback from resident regarding the 21-day planning consultation period – CIIr Crossley

Cllr Crossley explained the feedback received. The clerk explained that where necessary, there was the option to ask AVBC for an extension to the consultation deadline, or arrange an extra-ordinary meeting, so that planning applications can be commented on.

4238. Planning Matters – Planning applications for consideration

AVA/2022/0013	Land Adjacent Waterworks House Main Road Lea Matlock Erection of 2 dwellings (This application may affect the setting of a Conservation Area)
	COMMENT: Objection: The Council has received notice of substantial concerns amongst residents of Lea relating to Application AVA/2022/0013 and AVBC will be aware of several detailed objections that have been submitted in recent days.
	The Parish Council has considered presentations from local residents at its February meeting and we also seek to register an Objection to the proposal and cite three groups of concerns.
	Firstly, there are several inaccuracies in the various submission documents (the Heritage Statement particularly),

which are sufficient to render them invalid. The most pronounced are those which fail to recognise the position of the site within both the designated **Special Landscape Area** and the area designated as of special **Landscape Sensitivity**. The site clearly lies within both as can be referenced by Map 6 and 6a on pages 19 and 20 of the DLH Neighbourhood Plan. We would also wish to draw AVBC's attention to Document 199453 in Planning Application AVA/2009/1029 where Derbyshire Wildlife Trust indicate the significance of both Swinepark Woods and Lea Brook as designated Wildlife Sites AV066 and AVO67/3. Both of these sites abut the proposed plot.

The plot also lies within the Conservation Area and Derwent Valley Mills Buffer Zone. We note that AVBC's own Conservation Area Character Statement for DL&H states: "Most historic houses in the Conservation Area retain original chimney stacks and these are often of brick rather than gritstone which forms the principal building material. Such chimney stacks add interest to the skyline and contribute to the character and appearance of original houses. Similar stacks appropriately detailed with protected oversailing courses should therefore be incorporated in the design of new houses." (The larger of the Heritage Statements points this out at para 5.5, but the proposed designs do not reflect the Statement). We would also point out the proximity of the site to clusters of nearby listed buildings surrounding Lea's village green and we are concerned at the statement at 5.15 of the Heritage Statement that there is no impact upon them: we would argue that there is impact if Conservation Area design principles are not adhered to.

Additionally, we are significantly concerned by the Design and Access Statement's stated use of buff brick for the structure with gritstone headstones and sills. Conservation principles set out in AVBC's DLH Conservation Area Character Statement determines: 'In general, all new development should respect the character and styling of existing adjacent or nearby buildings which pre-date the 20th Century, rather than more recent developments.' Councillors were particularly vocal on this point as Lea has, prior to the design guidelines contained in Conservation Area Statements and NPPF and Neighbourhood Plans, been subject to building developments which have not always contributed to the visual enhancement of the area or respected its heritage.

Additionally, we note that, in the section 'The Location of New Development' in the Character Statement, that "Development will not be acceptable if it encroaches on the Special Landscape Area (or) the setting of Listed Buildings..." We therefore are of the view that the application breaches this core principle of the Character Statement.

Secondly we are concerned at breaches of **design principles.** We feel that the proposal does not sufficiently respect the Arts and Crafts designs of its two neighbours (Waterworks House and The

Patchetts) particularly in the omission of chimneys. Whilst the overall roof designs echoes those of their neighbours, the absence of chimneys breaks the run. The Design and Access Statement diagram "Street Elevation View" omits the chimney detailing of neighbouring houses.

In terms of design, we are also concerned at the specification of 'hit and miss' two metre wooden fencing on all but the front perimeter as the Neighbourhood Plan (page 69) is specific in recommending either stone walling or hedging to plot borders in Lea. There is also a conflict between the Design and Access Statement and the Planning and Heritage Statement at 5.9: the former states that the old field wall will be retained at its current height whilst the Heritage Statement states that it will be reduced. We would very much support the former.

Thirdly, we raise question about some undefined aspects of the application form as presented. There is no definition of foul water disposal (section 13), no detailed treatment of the question of runoff (other than to state 'soakaway') on what is a steeply tilting site as it reaches Lea Brook at the rear of the plot (section 11), and most particularly, no consideration of the biodiversity impacts of the proposals (section 12) in what is one of the last ancient fields within the curtilage of the village. The previous correspondence (Document 199453 in Planning Application AVA/2009/1029) fro Derbyshire Wildlife Trust makes the case regarding a proper biodiversity and wildlife audit which the application makes no reference to. We also indicate concern regarding there being no treatment within the application of existing trees and hedges (section 10) (again Document 199453 is relevant) rather than their replacement by timber fencing, nor any discussion of the impact of the views from the roadway towards Patchett Wood and Swinepark Wood which, as stated, both abut the proposed site at the rear.
