4622. Public Speaking

Cllr Stevenson read out a statement from Chris Henning (DCC) about the Leashaw landslip and road closure that was received by Cllr Taylor on 14 July 2023. It stated that the road would be re-opened to one lane of traffic with traffic lights providing, safety concerns are met. If this is the case, this will happen in a matter of weeks rather than months. (The full statement is available on the Parish Council website).

Cllr Taylor explained that the statement was only received on Friday and he hoped that the road would be re-opened in a few weeks with traffic lights. In response to a question about funding, Cllr Taylor confirmed that DCC had budgeted for the work, however, he wasn't sure whether a contractor was in place.

In response to a question about funding for the complete restoration of the landslip and the road, Cllr Taylor confirmed that DCC had budgeted for the work, however, he wasn't sure whether a contractor was in place.

Several members of the public asked questions and raised points about Leashaw landslip and the road closure. People asked why the road couldn't have been opened

sooner and why DCC had waited until now. One person said there appeared to be a battle between DCC and STW. The issue of potholes was raised on the diversion routes, especially High Lane. Questions were also raised as to who (DCC or STW) was monitoring the road for further movement and the reason for traffic counters on Bracken Lane.

Cllr Taylor confirmed that the new Cabinet Member for Highways is Councillor Charlotte Cupit. It was suggested that funding, reports, the design solution, reason for traffic counting and a date for re-opening could be raised.
