Councillor Stevenson declared a personal interest in Item 24 – Financial Matters (Reimbursement for edgings) and indicated that she would remain in the meeting but not participate in any discussions or vote.

Councillor Ward declared a personal interest in Item 25 – Planning Maters (AVA/2023/0728/729) and indicated that she would remain in the meeting but not participate in any discussions or vote.

**RESOLVED:** To approve the minutes of the meeting held on 4 October 2023.

- 4720. Chair's Announcements

The Chair announced the resignation of Cllr Wright due to health matters. She was thanked for her huge contribution throughout her time as Parish Councillor and we are

sorry to lose her. Cllr Wright has indicated that she will still be active in the Parish and she is always happy to help with anything she can.

Mr Hannath was thanked for putting up the lamppost poppies again for Remembrance Day, this is appreciated by the whole parish.

The Chair thanked the donor of the 100kg of daffodil bulbs for Long Lane and all the volunteers involved in planting them, as this was a massive task.

4721. To pass on thanks to the donor of the bulbs for Long Lane and acknowledge the volunteers who helped with the planting

**RESOLVED:** For the clerk to pass on thanks to the donor and all the volunteers involved with planting them.

4722. Update on Leashaw landslip including re-opening the road to single lane traffic, the provision of a full remediation plan and timescales from DCC and feedback from the meeting with Cllr Cupit on 31 October 2023

The Chair confirmed that the site meeting called by the PC took place on 31/10/23 and was attended by Parish Councillors, Cllr Cupit, Cabinet Member - Highways Assets and Transport at DCC, Cllr Taylor – DCC Local Councillor and the Director Highways from DCC.

Cllr Farnsworth drafted a full set of notes from the meeting and these were circulated and would be put on the PC website. The summary from the notes was: -

- there may be a one-way traffic scheme in place by Christmas 2023;
- there may be a practical engineering design that would support two-way traffic in place by late spring/early summer 2024;
- there may be works underway to finally stabilise the road and re-surface it ready for full two-way traffic by late 2025/early 2026.

Concerns were raised with the continued lack of progress from DCC and all the caveats and provisos they have stipulated in getting the road reopening to one-way traffic and the engineering solution and timescales to get the road fully reinstated.

**RESOLVED:** (1) For the clerk to send the meeting notes to the external attendees to give them the opportunity to comment before they are published. (2) For the clerk to add the notes to the PC website over the weekend (4/5 November). (3) To contact Crich Parish Council to suggest a joint approach and working together in getting Leashaw re-opened to traffic and fully reinstated.

4723. To consider calling a public meeting in December if Leashaw has not been reopened to single lane traffic and a full remediation plan and timescales provided by DCC by 1 November 2023

**RESOLVED:** To defer this item to December.

4724. Update – Response from Severn Trent in relation to their apparent withdrawal from the Leashaw landslip remediation plan that they outlined at the Annual Parish Meeting in April 2023 and whether they had a design solution in place

Parish Councillors noted the content of the letter from Severn Trent and expressed disappointment with the response. The discrepancy with the dates described was also highlighted, as it says the road could have reopened from 28th September, but they only advised DCC they could do so in October.

# 4725. Consider a response to the offer of help from Sarah Dines MP with the Leashaw landslip and road closure and also consider an invitation to the PC meeting on 3 January 2024

**RESOLVED:** For the clerk to send the draft letter that had been prepared to Sarah Dines MP which includes an update on the current position and invitation to meet on site and an invitation to the PC meeting on 3 January 2024.

#### 4726. To note the Report on the plan to wind-up the DLH Heritage Group

**RESOLVED:** To note the report.

#### 4727. Consider projects to improve the Parish

Cllr Stevenson confirmed that she had contacted Western Power Distribution and the old power supply is still available at the old telephone kiosk. Clarification on metering and the charges for the use of electricity have been requested.

**RESOLVED:** To defer a decision on the outdoor gym equipment to the December meeting. (2) For the clerk to contact Pickering PC for feedback on their gym equipment. (3) For the clerk to contact Fresh Air Fitness for details of other PCs who have purchased their equipment, so they can be contacted for feedback. (4) For the clerk to contact Community Heartbeat Trust for a quote to supply a defibrillator on the outside of the telephone kiosk and ask whether they do installation.

#### 4728. Update on Speed Indicator Device project – Cllr Dennis

Cllr Dennis confirmed that a site meeting had been arranged with DCC for 3/11/23 - 11am near the Jug and Glass so that the locations can be discussed. The clerk advised that the Object Licence application was submitted to DCC 19/10/23, but would need to be amended to show the modified post locations. A decision is needed on which quote to go for before the funding application is submitted.

**RESOLVED:** To defer a decision on which quote to go with to the December meeting.

4729. To note the response from Kompan confirming that it would not be feasible to replace just a small area of safety surfacing around the end of the slide with an alternative product. To consider the quotes to replace the surfacing for the whole area, or whether to retain the existing surfacing

**RESOLVED:** To retain the existing surfacing.

# 4730. To consider accepting the £350 grant from Cllr Taylor for the provision of the DLH Christmas tree

The environmental impact of chopping down and disposing of a sizable tree was discussed. A number of residents had raised concerns about this. Concerns were also raised about the cost of the tree.

**RESOLVED:** (1) To accept the grant from Cllr Taylor, but query what needs to happen with unused funds. (2) To proceed with a re-usable Christmas cone, rather than a tree.

### 4731. Update on the implementation of 'No Waiting at Any Time' restrictions to deal with the dangerous parking issue on Lea Road

The clerk confirmed that DCC were progressing the implementation of the restrictions, but no timescales were given. This has been requested, but no response had been received. A video showing the roadside parking and the empty car park had been provided by a resident and this was forwarded to DCC. As a result, DCC said they were looking internally at the parking charges at the car park

**RESOLVED:** To add this item to the December agenda so a further update can be given.
