# 4935. Litter and broken glass on the play area – Cllr McDonald

Cllr McDonald reported that litter and broken glass was present on the play area after the Bank Holiday weekend. In addition, one of the fence slats had been kicked in. This appeared to coincide with the re-opening of the pub. Also, it was suspected that foxes had pulled out the bin contents. The broken glass has been picked up, although this was a difficult task. In addition, the fence will be repaired. The bin has been moved higher up the post to make it more difficult for foxes to access.

#### 4939. Update – Painting of telephone kiosk, Lea Main Road

Cllr Stevenson gave an update. The majority of painting is complete, although some further work is needed. Volunteers were thanked for their efforts.

# 4940. Update on the implementation of 'No Waiting at Any Time' restrictions to deal with the dangerous parking issue on Lea Road

Although the order was in place on 13 May 2024, DCC have still not yet provided the road markings or signage.

# 4941. Update on Speed Indicator Device Project – Cllr Dennis

The clerk confirmed that the corrected Objects Licence has been received from DCC. The funding agreement has also been received from Derbyshire PCC for signing.

**RESOLVED:** (1) For the clerk to proceed to sign the funding agreement from Derbyshire PCC and mention the date issue. (2) For the clerk to place the order with DCC for the purchase and installation of the post for the SID and ask them to liaise with Cllr Dennis regarding the exact location.

### 4942. Update on bench installations - Cllr Stevenson

Cllr Stevenson confirmed that there were no updates at the present time. The clerk chased DCC on 6 May for an update on the Objects Licence for the bench on Nightingale Close, but has had no response.

**RESOLVED:** For the clerk to contact AVBC to ask if they would consider creating a bench out of the brick wall that was around the bottom of the recently removed timber bus shelter opposite Lea Primary School.

# 4944. Planning Matters – Planning applications for consideration

# AVA/2024/0225 Pine Tree Cottage Yew Tree Hill Holloway Derbyshire DE4 5AR

Two storey side extension with photovoltaic panels to roof and air source heat pump to rear and raised patio to front and side (may affect the character and setting of the Conservation Area and setting of a Listed Building)

#### **COMMENT:**

The Parish Council objects to this application on the grounds that the proposed exterior cladding materials contravene the design principles criteria set out in the DLH Neighbourhood Plan.

We have, on several occasions, drawn AVBC's Planning Department's attention to the principles set out in the Neighbourhood Plan for the Parish on pages 65-77 'The Importance of Good Design', and in particular the section on materials: 'A simple palette of materials should be maintained for the village, with sand and gritstone the predominant finishes. Quoin detailing should be utilised to add visual interest and richness.'

The Parish Council always views the use of timber cladding as contrary to these principles and a significant diminution of the visual amenity afforded by the diverse collection of vernacular buildings already present in the parish. This is of particular importance in the sensitive location of this application because Pine Tree Cottage is one of a cluster of very old buildings which were former agricultural, quarry or smelter's cottages built to serve workers in Holloway's early industries in the late eighteenth century. It is connected to a small run of ancient buildings which commences with Yew Tree cottage which is Grade II listed and cited as incorporating elements of a C17th building. The random placings of these buildings in what was a small slope of cottages creates a special amenity environment and is one of the most original and unspoilt locations in the parish. The proposed extension will detract from the visual amenity of the village when viewed across part of Lea Hurst's parkland from the Public Footpath 32.

The application itself practically doubles in size the current stone-built cottage, proposing a chalet-style addition that is timber-clad, has a a roof over-run to shelter timber decking and slate-like roofing materials that incorporate PV panels. It is therefore a completely modern addition to a conservation-grade building. The parish council views this as an inappropriate and, in NPPF terms, views the application as generating harm to this heritage asset, harm that is less than substantial but which nevertheless significantly damages the public amenity benefit present within this cluster of cottages. We do not agree with the Planning Statement of the application that, in this case, 'public benefit is derived from the upgrading and safeguarding of a heritage asset.' In our view, the submitted Heritage Statement underplays the distinctiveness of this property and the group of which it is a part, failing to mention the Listed status of the neighbouring property, Yew Tree Cottage.

We note that Policy LS3 of the AVBC Local Plan ~ which is still current ~ requires all development proposals to reflect the principles of good design, by:- a) conserving or enhancing the quality of local distinctiveness of the natural and built environment; b) respecting the character of the locality in terms of the scale and nature of development, its layout, density, height, massing, architectural style, materials and landscaping; c) taking account of the relationship between the development proposals and neighbouring buildings, and the spaces between and around those buildings.

We urge AVBC to take into account conformity with the principles set out in the NPPF, The National Design Guide, the Saved Policies of the AVBC Local Plan, the DLH Conservation Area Statement and DLH Neighbourhood Plan as they apply to this application and to consult with the applicant and his/her agent with a view to the creation of a gritstone extension that matches the vernacular style of the existing cottage and the cluster of cottages of which it is a significant part, including the Listed Yew Tree Cottage.
