However, as one of the applicants was unexpectedly unavailable for the meeting the Chair tendered the Council's apologies to the two candidates present explaining that Members would consider all three at the August meeting.

4960. Update on Leashaw landslip and consider any follow up actions

An update was received from DCC on 30/6/24 and has been added to the PC website. There has been no response from the East Midland Mayor regarding funding for the reinstatement of the Leashaw. The response to the FOI/EIR request sent to DCC has revealed that there is no capital funding allocated for the reinstatement of Leashaw. The business signage has now been installed.

RESOLVED: (1) For the clerk to invite Cllr Cupit and Cllr Taylor to the next PC meeting to outline the findings from the geotechnical ground investigations, implications for design solution, next steps and the budget allocation 2025/26 for the reinstatement of the road. (2) To add an item to the next agenda to consider petitioning the Secretary of State for Transport regarding the reinstatement of the road. (3) For the clerk to contact the East Midlands Mayor to ask if a response could be provided to the email sent to her on 30/5/24.

4961. Consider concerns raised regarding the Parish Magazine

In addition, to highlight that no acknowledgements are received when articles are submitted and recently, no responses have been received when the editor has been contacted. For the clerk to emphasise that the Parish Council is very grateful for the work undertaken, but respectfully ask if the feedback could be used to improve the service.
