#### MINUTES - 2 April 2025

Minutes of Dethick, Lea and Holloway Parish Council Meeting held in the Florence Nightingale Memorial Hall, Yew Tree Hill, Holloway on Wednesday 2 April 2025.

**5164.** To accept apologies for absence - Cllr Farnsworth and Cllr Jakubait

**RESOLVED:** To accept all apologies received.

#### 5167. Public Speaking

Cllr Taylor commented on the latest Leashaw update from Cllr Cupit and explained that the area around the landslip had been tidied up in preparation of any work. Cllr Taylor also explained the Local Government reorganisation options and described it as 'scary'.

Parish Councillors highlighted, that calls had been received regarding why 3 operatives had been working for 3 days moving the fencing near the landslip. Concerns were raised as to whether a tidy up was the correct description for what had been done and that no advance notification of the work has been received by the Parish Council. Concerns were also raised about the latest update, where the proposals come with a heavy caveat in relation to landowner approval.

#### 5171. Chair's Announcements

- The Annual Parish Meeting will be held on Wednesday, 7 May 2025 at 6.30pm
- After 6 years, Cllr McDonald has decided to step down as Parish Councillor and her last meeting be the one in May. Cllr McDonald is happy to help with tasks around the Parish.
- The clerk thanked Cllr Stevenson for repairing the Parish Council noticeboard.

#### 5172. Update on Leashaw landslip and consider any follow up actions

The Chair raised concerns that yet again the latest update from DCC had only been received a few hours before the PC meeting. The main points from the update are: -

- DCC have some additional funding from EMMCA next year under the new mayoral funds and some of this is to go towards landslip repairs.
- DCC are working towards the earliest possible start date.
- DCC officers will stack and run tasks in parallel more to make every attempt to condense the timeframe.
- The consultants now have a project manager to co-ordinate the additional aspects such as the land ownership agreements etc.
- A timetable to June was provided.
- DCC are looking at whether the contract could be broken up into smaller contracts
  which would then potentially allow some of these to start on site rather than procuring as
  one which would take slightly longer due to the contract and project size.
- There is a heavy caveat and a lot that could derail proposals but they are doing
  everything possible to start on site this year, but the project will not be completed this
  year. The aim is to start on site if possible and then continue works for as long as the
  weather allows, and then complete next year.
- Following representations from residents, DCC have carried out a bit of a tidy up of the signage and barriers on site, as well as a sweep of the Crich end and gully cleanse.
- BT will replace a pole in the near future, on the footway outside Ivy Cottage.

**RESOLVED:** For the clerk to ask DCC for (1) A project plan / timeline covering tasks right up to completion. (2) Future updates to be provided at least 48 hours before PC meetings. (3) Advance notification of works where possible. Also, for Cllr Stevenson to discuss PC concerns directly with Cllr Cupit and report back to the next PC meeting.

### 5173. Confirm specification for timber bollards on triangle opposite Florence Nightingale Memorial Hall

#### 5182. Planning Matters – Planning applications for consideration

# AVA/2025/0153 Cartref Mill Lane Holloway Single storey front extension and 2 storey rear extension (may affect the character of the conservation area) COMMENT: (Delegated to Cllr Stevenson) Objection. The Parish Council has several concerns in relation to this development. Cartref is a quirky and characterful cottage, being one of a pair that sits directly opposite the junction with Church St. Consequently, it plays a leading role in the character of the immediate and very open area in the heart of the village. This 175 years old cottage was a dwelling house and post office until the 1970's, making it an important part of our social history. Although there are some modern developments near to Cartref, there are many more traditional properties, to the north and east,

making up the majority of this part of the village. The proposed combined front extension and plant room would present a considerably tall structure built right up to the edge of the highway. This would take away from the frontage of the building in it's present form and have a negative impact on the street scene. It would completely alter the facade of the building, unbalancing the pair of semi-detached cottages and creating a disproportionate mass at one end of the buildings. Much emphasis has been put on the access and steps in this application but this will always be an issue with a cottage built on a hillside. The renovations cannot remove the need for steps nor futureproof for the frail and elderly, as suggested. If safety is the main concern, then reconfiguration of the steps could easily be achieved, without the addition of an extension. In relation to the changes at the rear of the property, comparisons have been made with the recent extension built on the Old Coach House on Yew Tree Hill. The proposed changes at Cartref are of similar style. It should be pointed out that Cartref originates from the 1850's, unlike the Old Coach House which was actually built in the early 1990's and has no historical value. The proposed alterations would be clearly visible from footpath 42. This traverses the parkland which forms part of the setting of Lea Hurst, a listed building. The traditional appearance of the rear of Cartref would also be negatively affected by the removal of the chimney stack. The Conservation Area Statement refers to chimney stacks adding interest to the skyline, which contributes the character and appearance of traditional houses. The Heritage Statement attached to the application refers to a past application from 2020, which makes it irrelevant. The proposed alterations do not preserve or enhance the character of the property in the Conservation Area. It is hoped that The Heritage Officer will consider the impact of the substantial changes proposed to both the interior and exterior of this building. 	The removal of one Ash tree and the limb removal of a separate Ash tree. The Ash that we are applying to remove (T1) has a heavy lean over my clients wall, public footpath and frequently used road. Our concern is that with the added weight of leaves and particularly strong winds in this area that the tree will uproot and cause structural damage to my clients property. We are also concerned that it overhangs a public footpath and road frequently used by pedestrian vehicles. We are also applying to remove a single limb from a separate Ash tree (T2) as my client has concerns that larger vehicles using the road are in danger of making contact with this particular limb. If accepted the work would be carried out by Evergreen Treescapes to British Standards.
